- c. Update on Region 3 Assembly and OA Convention Cindy C.
  - i. The program has been developed. The main task now is to assign speakers and workshop leaders.
  - ii. Costs for registration materials will be between \$330-\$400. This will include the tote, notebook, pen, copy of the program.
  - iii. There will be a bulletin board with a section for Sponsor/Sponsee notes as well as Hospitality Room hours. They plan on posting the map of the hotel, a map of local restaurants rather than making individual copies to save paper. A few copies of the hotel layout and local area restaurants will be on the registration table. There will also be a poster-sized copy of the program on display. They will be sending out email information to registrants through Constant Contact.
  - iv. The convention treasurer reported that their working balance is \$3,197.

- v. The hotel has a pool, hot tub, gym and restaurant
- vi. Because of the increased cost of the banquet meals, the registration fees may not cover all the expenses. The Northern Colorado Intergroup does have sufficient funds to cover any losses.
- vii. They are creating a bookmark for attendees to take home.
- viii. They will have a hospitality suite.
- ix. They have been marketing the convention to local OA groups, Region 3 member intergroups and WSO.
- x. They will have a free table of used conference approved books donated by groups or individuals.
- xi. For entertainment, they will have Karaoke.
- d. CCIG Board elections Ruth
  - i. Jan B. thinks that Mike K. is interested in being the Region 3 representative. Since he was not at this meeting, she will contact him.
  - ii. Lori C. said that an OA member told her that she may be interested in the Region 3 position. Ruth said that this person would need to fill out the application on OADenver.org website. Lori will follow-up with her. Jan B. volunteered to talk with the person. Lori will give her Jan's phone number.
  - iii. Elections are normally in September for the CCIG board, Region 3 representatives and committee chairpersons. We decided to postpone the elections until the October intergroup meeting in order to find more candidates. Ruth will send out an email with the application for all the positions and give a deadline of September 30, 2022 for them to be returned. Ruth suggested that we approach people one by one and ask them if they would run for a service position on intergroup. She said that if each of us could recruit 2 people, we could fill all the positions. iv. Jan B. said that our intergroup has budgeted \$2,300.00 per Region 3 representative for World Service. That money pays for the representative's registration, room and transportation to the assembly and convention. The responsibilities for the Region 3 representative are to attend all the assembly meetings Thursday and Friday. They have to bring a report back to the intergroup about what was discussed and decided during the assembly. Whoever wants to apply for the Region 3 representative position needs to complete the application, attend the October CCIG meeting, be voted in, attend all the assembly meetings and give their report at the November CCIG meeting.
