# a. Communications & Technology Committee – Heidi B., Matt E., Dana B.

i. Thank you to Linda for coordinating and managing meeting list updates. Thank you to Carolyn C. for zoom accounts coordinating. Thank you to Matt E. for adding an event to <u>oadenver.org</u>. Thank you to Shannon G. for com/techcontent updates. Thank you to Dana B. for creating and sending the email campaigns, Leslie for doing 2 posts.

ii. We meet via Zoom on the 3rd Wednesdays each month. Most com tech positions take 1-2 hours per month and can be done from home. # b. Region III Rep/WSBC Delegates – Bev J., Mike K.

- Bev J. said that going to the World Service Business Conference was a humbling experience. This was her first time. She believes OA is in good hands. There were 176 eligible voters from 14 countries including Ukraine, Russia, Sweden and Australia. They had a paid professional parliamentarian to guide the meetings. Delegates said the serenity prayer in their native languages. There were calls for prayer during discussions and voting. People were passionate about their ideas.
- ii. Bev said that it was decided that OA will sell recovery chips for years 1-20, 25, 35, 40, 45 and 50. Medallions can be engraved with any year on the oa.org website. Another decision was for OA meetings to encourage the use of all OA literature.
- iii. At the conference, Mike was on the Young People's Committee. OA has a website for young people, oayoungpeople.org. There are 15 meetings worldwide, 9 in the U.S., 3 in Iran and 3' in Greece. Young People meetings are for people from ages 18 to 30 years old and for members that joined OA when they were between 18 and 30 years old.

- iv. Mike K. said that there is an OA website for men in OA. It is OAmen.org. It has a list of online and face to face meetings for men. There is email discussion and phone outreach.
- Mike K. said Diversity was a hot topicat WSBC.. There are underserved communities including Latino and people of color. There were 7 delegates who were over 80 years old. Virtual World had quite a few delegates including 1 from Northern Colorado Intergroup and Pikes Peak Intergroup.
- vi. Mike K. said that he was elected as a trustee and will be working with the WSO Public Information and Professional Outreach Committee. CCI will need another Region 3 Rep/WSO delegate to replace him, because he can't do both positions. Another person from Colorado is a trustee, BJ. She has been a trustee for a while. In 2024 the WSBC will be face to face in Albuquerque with virtual listening only. In 2025 WSBC will be virtual only. Mike and Bev will provide a written report about the conference next month.

# c. Twelfth Step Within - OPEN

- d. PI/PO Shannon G.
  - i. Shannon is thankful for the people that helped with the 365 Health Fairs. Carrie G. was enthusiastic and really helped her get organized. She feels that having an OA presence at the health fairs is worth doing. OA had to compete with other organizations to get a table at the health fairs. The tables for non-profits were limited. Jena was able to get a table at one location because she had a contact at the church. We went from 1 fair last year to 4 this year. There were new pamphlets left over that can be used next year.
  - ii. Shannon's next project will be to create a public service announcement for radio and TV.

- f. Young People's Committee Shanna F.
  - i. Shanna was not present but let Carrie know that she is considering starting a Young People's Zoom meeting.
  - ii. Mike K. will send Shanna the contact information for the Chair of the Young People's Committee at World Service. Shanna can use the CCI Zoom account to start a meeting.

## 11. New Business

Sponsorship Day August - Carrie said that OA hosts an annual Sponsorship Day in August. Carrie urged everyone to encourage people in their meetings to volunteer to be the Twelfth Step Within chair so an event could be planned for this day.

## 12. Old Business

- a. Ad Hoc Merger Consideration Committee- Cindy C. gave a report
  - i. Cindy contacted Francene (now living in the UK) about a Phoenix area merger from (approximately) 10 years ago. Their experience was the following
    - Merged HOW, 90-day, and 'regular' (sorry, Mike) OA in the Phoenix area; not different regional areas.
    - Reason: to fill IG positions
    - Tension at first; resolved by group conscience
    - First meeting was contentious (at chair level)
    - Attendance was open to all and the room was full
    - Merger took 15 months.
    - All chairs remained in OA after the merger.
    - Banking issues took the longest to resolve merging accounts, legal issues (needed an atty).
    - Merger folks met every 4-6 weeks. Everyone was invited to attend.
    - Encouraged everyone to share their fears.
    - Problems got resolved were able to fill all the service positions
    - Only 25% attendance by IG reps before/after the merger.
    - Name of the combined IG came from suggestions and was decided by voting.

- Voting on the merger was done at each separate IG meeting.
- Suggestion: discuss peoples' ideas and concerns off the record. Share the benefits of the merger.
- Not aware of any groups that chose not to affiliate with the new intergroup after the merger.
- Kept the IG meeting space of the IG that had a lease.
- Difficulty with bylaws: especially re. Definition of abstinence for service positions.
- ii. Bylaws of the intergroups that merge would have to be combined, then approved by WSO.
- iii. Mike talked to R4 trustee:

 $\circ$  MN Twin Cities IG's merged (HOW and 'regular'). Zoom IG meetings; difficult to get meeting reps to attend. Other IGs in MN disbanded.

 $\circ$  Some lowa IGs merged. Some dissolved. Issues: a fraid they wouldn't have representation or be ignored. A trust issue.

• UT: one IG died. Challenges between Salt Lake City and Provo.

- iv. The primary advantage of merging is to lessen the service burden.
- v. The action items for the committee were to check on the business status of the intergroups and compare Bylaws. The next meeting is May 9th at 4:00 pm on Zoom.
- b. Ad Hoc Committee Bylaws & PP Update

Mike K, Lori C and Carrie G. have met three different times, and have finished updating the Policy and Procedures manual. They are nearly done with updates to the Bylaws, and plan to have it done before the next CCI meeting on June 6th.
